

### 41/2020. (III. 11.) Government Decree



#### 41/2020. (III. 11.)

Government Decree on the security of life and property in the event of an emergency in order to secure the health and life of Hungarian citizens.

Students are prohibited from entering higher education institutions until revoked. During the curfew, higher education institutions must ensure continuity of education.

At the request of the Secretary of State for Higher Education, higher education institutions have developed an institutional action plan by 16 March 2020 to ensure continuous distance learning.

### Survey of difficulties faced by higher education institutions in emergencies (25 March 2020.)



- 1. Problems with the availability of electronic curriculum
- 2. Problems with the availability of information technology and communication teaching tools
- 3. Problems related to knowledge transfer and learning methods, use of digital teaching materials
- 4. Problems with human resources related to the organization of distance education
- 5. Problems with students' participation in distance learning
- 6. Problems related to the provision of infrastructural capacities and conditions of training organized as distance education
- 7. Problems in organizing practical training as distance learning
- 8. Problems with the organization of foreign language training as distance learning
- 9. Problems other than those listed

### Survey of difficulties faced by higher education institutions in emergencies (25 March 2020.)



Based on the received questionnaires (43 responses were received), it can be stated that the vast majority of the trainings take place in the absence of contact classes.

 According to the feedback from the institutions, 45.6% of the trainings are complete and a further 52.2% are at least partially successful, and only 2.2% fail.

#### Reasons for failed trainings

- lack of computer equipment;
- lack of adequate computing skills of teachers;
- inadequate bandwidth for internet subscriptions.

#### "Exit" strategy for the higher education sector



#### Presidents of the European Commission and the European Council 15 April 2020

- a common European roadmap for tackling the COVID-19 epidemic;
- abolish general emergency regulations as soon as possible.

### The exit strategy of the higher education policy field from the COVID-19 epidemic

- it gradually brings education and institutional management back into the order of operation after the end of the emergency;
- ensuring the most optimal conditions for all actors in the sector to start the 2020/2021. academic year in September 2020.

## Higher education mobility programs and collaborations (joint trainings, research, professional programs)

- in the light of the measures taken by other Member States;
- completion of admission procedures by 31 August 2020;
- enrollment does not require physical presence, ensuring the establishment of a student legal status;
- starting training in distance / digital education.
